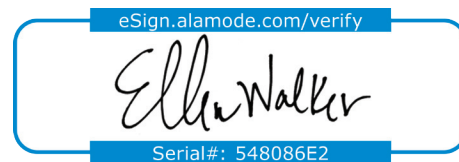

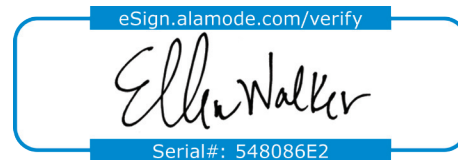
Instructions to Notary Public for the Identity Verification Offline Authentication Form

By notarization of the Digital Certificate Offline Authentication Form ("Form"), you will assist in the authentication of the individual presenting the Form, herein referred to as the Subscriber. The Subscriber has applied for an electronic signing certificate for use in signing legally binding documents. This certificate is a legally binding signature under applicable state and federal laws.

As the notary, you are charged with the responsibility to check the validity and integrity of the Subscriber's documentation listed below. All documentation must be in the subscriber's name. After all of the subscriber's documentation has been checked and the Form been signed and notarized, please perform the following:

- Fax a copy of the form and a photo copy of a valid driver's license (or other form of government generated photo ID card), front and back (unless blank), to 1-866-619-7431.
- You can also scan a copy of the form and a photo copy of a valid driver's license (or other form of government generated photo ID card), front and back (unless blank), and email it to Domains@alamode.com.
